- **4 A summary was made of the aim of the Society and the activities** in which it is currently involved, and of those in which it might find a role in the next year:
 - organisation of two public meetings Spring and October (latter also AGM) 25th
 March 2004 was suggested as a suitable date for the Spring Meeting 2004, and 4th
 November for the AGM & Autumn Meeting. Subjects for both meetings were
 deferred.
 - monitor planning applications and respond as appropriate

- Traffic Management Scheme (initiated by WSoc, and now the subject of a joint Working Party, with Warnham Parish Council). Public consultation at exhibition in January.
- A24(Daux to Capel Road Improvement Scheme) Liaison Group of which WSoc is a non-statutory consultee. Response already to probable 'Recommended Route'.
 Major response required during the statutory consultation period.
- Gatwick development we are members of GACC and have responded to the Government's Consultation paper on Airport Development.
- WSCC Waste Plan-non-statutory consultee. Brian King & Tony Hull expressed interest in this topic.
- Horsham District Local Plan, which sets out development in the District up to 2016.
- Input into HDC prior to Local Plan by starting work on a Village Design Statement (VDS), as a prelude to a Parish Plan.
- Attend meetings organised by other bodies
