The Footpath Map (Mr Purcell): HDC's approval of our proposed format is still awaited. WPC has guaranteed the set-up costs. Costs of printing and plastic wallets need to be covered. Mr Hamer & Mr Purcell will pursue

## 7. Any Other Business:

a. It was agreed to take no action in respect of the planned doubling of capacity of Warnham brickworks. Our concern about the impact of increased heavy traffic is unlikely to carry any weight with WSCC

b.HDC has deferred a decision on an outline planning application by Berkeley Homes on land east of the A24, part of the West of Horsham development. At issue is the number of affordable homes to be provided, a concern of the two developers. Elsewhere the Secretary of State has dismissed two appeals that failed to provide 40% affordable housing, twice as many as envisaged for east of the A24
