THE WARNHAM SOCIETY

Minutes of the 172nd Meeting held at Forest Grange on Wednesday 15th August 2012.

- 1. Apologies for Absence: Mr Hamer.
- 2. The Minutes of the Last Meeting, 12th June 2012 No.171 were approved.

- 5. Finance (Miss Lee): The bank balance stands at £825.36.
- 6. Membership (Mrs Bridges): The leaflet An Invitation To join The Warnham Society has been circulated to all Parish households, resulting in a few new members. It has also reminded people of the Society's existence & history. The membership list was audited for anomalies, there are 59 paid up members. It was agreed that Mr Lancaster & Miss Lee would open a Twitter account as an added means of communication with & from the Society. The question of increasing membership fees will be discussed at our next meeting.
- 7. Parish Council: The opening of the website was warmly welcomed.
- 8. Roads & Traffic: The submission of the WPC Survey to WSCC & its publication on the WPC wesite was noted. The Society remains concerned at the lack of a more comprehensive approach to the impact on Warnham of the BBH development. Nonetheless, it joins the WPC in hoping for a positive response from WSCC.
- 9. Planning:

- Waste Local Plan: Mr Elliott & Mr King have submitted a response supporting the WPC's stance, with added comments.
- Consultation on the Draft Sustainability Appraisal WLP: Mr Elliott & Mr King were authorised to respond on behalf of the Society.
- 10. Autumn Meeting & AGM: The Meeting will take place on Friday 19th October 2012 in the Village Hall, 7.30 for 8.00 pm. The Vicar, Christopher Loveless, will speak on the history of pantomime. Mr King will agree with the Vicar the question of any fee or charitable contribution.

Immediate publicity for the talk & AGM will be secured by a notice in September's Warbler to be prepared by Mr Lancaster & Miss Lee and submitted to the editor before noon on Saturday 18th August 2012.A repeat will appear in the October Warbler. Actions for wider publicity, eg to NADFAS, the church, HAODS, will be agreed at the September meeting. Admission will be free to members, visitors wil pay £3.Mrs Lee will prepare a poster for distribution highlighting the pantomime theme.

AGM Documents: It was agreed that, wherever possible, documents will be sent to members online with provision being made for members not online to receive the usual printed copies, either at the meeting or earlier if appropriate.
